Rules defined

2012 legislation - ESSSB 6284

Went into effect June 1, 2013

- FTA suspensions only for moving violations
- WAC 308-104-160 effective March 4, 2013
 - Moving and non-moving violations defined
- Prior to June 1st all traffic offenses
- WAC re-updated February 24, 2014

- 1st offense - 90 days
- 2nd /subsequent offense - 2 years

Refusal

- 1st offense - 1 year
- 2nd /subsequent offense - 2 years

Administrative Withdrawal - Minor

Breath/blood .02 or THC
zero ng/mil

- 1st offense - 90 days
- 2nd /subsequent offense - 2 years or until age 21

Refusal

- 1st offense - 1 year
- 2nd /subsequent offense - 2 years or until age 21

Criminal Withdrawal - Refusals

- 1st offense - 2 year revocation
- 2nd offense - 3 year revocation
- 3rd/subsequent offense - 4 year revocation

Criminal Withdrawal - Notice

Redmond VS Moore

- 45 days from mail date
- Not conviction date
- Cannot waive 45 days

Time Served

- Day for day credit for same incident

Criminal Withdrawal – No Action

RCW 46.61.503

Minor operates vehicle with Alcohol or THC

- Conviction on ADR
- Counts as prior
- Stays on record for life

- Based on conviction date

Deferred Prosecution

- Based on date granted

IID Cont...

4 month compliance (1-1-11 to 7-22-17)

180 days compliance (7-23-17 to present)

- No attempt to start vehicle with .04 BAC
- Fail to take or pass test
- Fail to appear at vendor

Vendor will report

- 4 consecutive months or 180 consecutive days from release date
- Do not remove IID until DOL has processed
- Removed early must start 4 month or 180 days all over

****WSP maintains the list of approved Washington State Vendors**

Cost of IID

From \$70 to \$100 a month

\$20.00 per month has been added to all drivers with and IID installed

- Indigent fund
- Assistance with IID
 - Installation
 - Calibration/maintenance
 - Removals
- Revolving account
- Fund impaired driving program for WSP

Who is eligible to apply?

Washington Licensed Driver

- Unexpired

Unlicensed Driver

- Will be required to test

Out of state licensed drivers

- Maybe required to test

Personal driving privilege only

- No commercial license or endorsements

Employer Exemption

Employer must sign

- Self employed drivers
- Leased or rented vehicle by employer
- Temporary care or maintenance of the employer

Driver must keep and carry copy with them at all times

DOL will not return copy to driver

It is not recorded on the driving record

Actions DOL takes

- Suspension
 - 364 days or less
- Revocation
 - 365 days or more
 - All tests required
- Disqualification
 - CDL only
 - 30 days to Lifetime
- Cancellation
 - 30 day to 10 years

Violation of mandatory court probation

One 30 days withdrawal for each citation not each charge

- **Driving without a license**
- **Driving without insurance**
- **Driving without an IID**
- **Driving with a BAC above legal limits**
- **Refuse to submit to breath/blood test**

FORMSITE data

- **Court date driver found in violation not incident date**

Will be added to longest withdrawal on record

Probationary License - \$50.00

Reinstatement Requirements cont..

Test

- Required if revoked for more than a year
- Required if CDL has been disqualified for more than a year

Submit medical/vision certificate

Compliance with child support

Submit Habitual Traffic Offender hearing

Supply proof of payment or payment agreement
